

**ADDRESS BY THE HON'BLE PRESIDENT OF INDIA  
SMT. DROUPADI MURMU  
ON THE OCCASION OF CALL ON BY

As we know, trade forms the backbone of economies. It promotes investment, creates jobs, drives economic growth, and improves standards of living. Trade discussion forms important part of almost all bilateral and multilateral meetings and summits. During my meetings with Heads of States and delegations also, trade related issues are discussed. Here I would like to share that India is at the forefront of global trade facilitation efforts. India is committed to digital and sustainable trade facilitation and you are going to play key role in trade promotion. You, the Indian Trade Service officers, are not just trade regulators, but are trade facilitators too.
